NO.HC(K)21/2020/Estt/ 2435 :::: Sealed quotations, affixing Court Fee Stamp of ₹8.25 (Non-refundable), are hereby invited from reputed local suppliers having permanent tailoring/ textile shops, registered local firms dealing in garments and based in Kohima for supply of the following liveries (uniform) for Grade-IV staff & chauffeurs of Kohima Bench of the Gauhati High Court at Kohima:-

1. (a) Readymade Achkan & long pant (terry cotton- good quality) in white colour.
(b) White turban (terry cotton- good quality)
2. (a) Similarly, Readymade shirt- white colour, short button up coat & long pant (terry cotton- good quality) in white colour for gents.
(b) Peak cap (good quality)
3. (a) Further, Readymade shirt- light blue colour & long pant- navy blue colour (terry cotton- good quality) for ladies.
(b) Shirt- light blue colour & long pant- navy blue colour (terry cotton- good quality) for gents.

TERMS AND CONDITIONS

1. The quotation closing date is 11:00 hrs of 16.06.2025 and will be opened on the same day at 13:00 hrs in presence of all the tenderers.
2. The tenderers are to quote only one rate for each item. The rate should be exclusive of G.S.T. The sealed quotation should be superscribed as "**Quotation for Liveries**" and addressed to: The Registrar, Gauhati High Court Kohima Bench, Kohima – 797 001, Nagaland.
3. The shops/firms/suppliers must be based in Kohima and possess a valid GSTIN. copy of GST registration certificate, trade license and PAN card must be submitted alongwith the quotation. Quotation without samples, proper specification of items and of inferior quality will be rejected outrightly. Samples of cloths should be at least of the size 6" x 4". The pattern of stitching, etc may be seen from the office of the undersigned on any working day before 16.06.2025.
4. The supply should be made within 30 days from the date of issue of supply order.
5. Quotation once submitted will not be allowed to be withdrawn till finalization of the whole matter. The office reserve the right to reject the whole quotation or item/ items or whole tender process without assigning any reason thereof. No conditional quotation will be accepted. The decision of the Registrar in all respect shall be final and binding.
6. In case of violation of terms and conditions or unsatisfactory supply of items or of poor quality and below standard, the Registrar, Gauhati High Court Kohima Bench, Kohima reserves the right to terminate the supply order with/without giving prior intimation to the supplier.
