No. HC(K)7/06/J-I/_____/::: Whereas the Subordinate Courts in Nagaland have been functioning in virtual mode vide Notification dated 22nd April 2021 which was issued in consonance with the Hon'ble Gauhati High Court Principal Seat Notification No. 28 dated 19th April, 2021, Notification No. 29 dated 20th April, 2021 and Notification No. 30 dated 21st April, 2021 which were extended from time to time with modifications. Further, vide Hon'ble Gauhati High Court Principal Seat Notification No. 61 dated 9th July 2021, guidelines were issued for the limited functioning of the Subordinate Courts of Assam which were extended to the State of Nagaland due to the prevailing COVID pandemic.

Whereas with the decrease in COVID cases in the State, the Government of Nagaland has begun the process of unlocking in phases from 1st July 2021. The fifth phase of the unlocking process has started from 19th August 2021 till 2nd September 2021.

Therefore taking into consideration the phased unlocking of the Government, the Subordinate Courts in Nagaland shall resume limited physical courts by maintaining all necessary COVID-19 protocols and restricting the entry of visitors with effect from 1-09-2021.
