State of Maharashtra), the Hon'ble Gauhati High Court is pleased to notify that all applications for bail and anticipatory bail pending before the trial courts under its jurisdiction are disposed of expeditiously, preferably within a period of two months from the date of filling, except in cases where delay in attributable to the parties themselves. Further, all trial courts shall prioritise matters involving personal liberty and avoid indefinite adjournments.

This Notification shall come into force with immediate effect.
