- 7. Candidates will have to appear for Written/ Practical and Interview/Viva voce to be held in Kohima Bench as and when called. No TA/DA will be admissible for that purpose.

Stage 2:	Practical	15 Marks	
Stage 3: Interview	Candidates in the ratio of 1:3 on the basis of performance in the OMR based written test and practical test may be called for the Interview.	15 Marks	

Final select list will be prepared based on the total marks obtained in both **Stage 1**, **Stage 2 and Stage 3**.

**Note:** In case of candidates obtaining equal total marks, one who obtains more marks in the written and practical test will be given preference. Where the marks obtained by such candidates in the written and practical test are same, the candidate who is senior in age will be given preference.

The Gauhati High Court reserves the right to fix cut off marks in the Written Examination.

#### 5. Terms and conditions:

- 1. Merely satisfying the eligibility criteria does not entitle a candidate to be called for the written examination/interview etc.
- 2. Candidates who are already in Government service shall have to produce "No Objection Certificate" from his/her employer.
- 3. The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before and after the selection process, it is found that a candidate does not fulfil any of the eligibility condition, his/her candidature shall stand cancelled without any notice. Mere

calling of the candidates to written examination/interview, etc. and mere issuance of admit card /call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage.
