- 2. B.Sc with 1 year Post Graduate Diploma in Computer Application from a recognized Institution and with at least 1 (one) year working experience from a reputed Institution/organization  ${f or}$
- 3. Diploma holders from Polytechnic in Computer Science/Engineering or Electronics & Telecommunications from a recognized institution and with at least 2(two) years working experience from a reputed Institution/organization.

- 4. Attachments sent must be in Microsoft Word (.doc) format only.
- 5. It is mandatory for applicants to have valid e-mail address as all communications will be made through e-mail only.
- 6. Incomplete applications will be summarily rejected.
- 7. Candidates will have to appear for Practical Skill Test and Walk-in-Interview to be held in Kohima Bench as and when called. No TA/DA will be admissible for that purpose.
- 8. The list of candidates with allotted Roll Nos. will be published in the High Court website for reference of the candidates in due course.

#### 4. Selection process:

Stage	Description	Marks
Stage 1:	Practical Skill Test	40 Marks
Stage 2:	Walk-In- Interview	60 Marks

Final select list will be prepared based on the total marks obtained in both **Stage 1** and **Stage 2.** 

**Note:** In case of candidates obtaining equal total marks, one who obtains more marks in the practical skill test will be given preference. Where the marks obtained by such candidates in the practical skill test are same, the candidate who is senior in age will be given preference.

#### Terms and conditions:

- 1. Merely satisfying the eligibility criteria do not entitle a candidate to be called for the written examination/interview etc.
- 2. Candidates who are already in Government service shall have to produce "No Objection Certificate" from his/her employer.
- 3. The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before and after the selection process, it is found that a candidate does not fulfil any of the eligibility condition, his/her candidature shall stand cancelled without any notice. Mere calling of the candidates to written examination/interview, etc. and mere issuance of admit card /call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage.
