

Minimum =18 years

Maximum =32 years

Relaxations:

- a. Scheduled Tribe (ST): 5 years relaxation (upper age limit of 37 years).
- b. Government Employees: Relaxation equal to years of service served subject to a maximum of 5 years.

The age limit will be determined as on the last date of submission of application.

3. Eligibility criteria and essential qualification: A candidate, as on the last date of submission of online application, must fulfill the following criteria:

- i. Must be an indigenous inhabitant of the State of Nagaland belonging to the District of Mokokchung, Tuensang and Phek.
- ii. Must possess the minimum educational qualification of Class-VII (7th) standard; and those who have passed HSSLC (12th) or above shall be ineligible to apply for the said post. On need basis, preference may be given to the candidates having special skill.

4. Selection Process:

| Stage-I | <u>Written examination:50 marks</u> Written examination(Objective type multiple choices) will be 1½ hour(ninety minutes) duration on OMR sheet and the same will contain questions on General Knowledge/Current Affairs, General English and General Mathematics of Class VII standard. |
| Stage-II | <u>Interview/ Viva-Voce: 20 marks</u> Candidates equal to 5 times the number of vacancies (1:5) in order of merit in the written examination will be called to appear in the Interview/Viva-Voce and verification of documents. A candidate must secure at least 60% i.e. 12 out of 20 marks in the Interview/Viva-Voce in order to be considered qualified. |
| Final selection will be made on the basis of the total marks obtained by the candidates in the written examination and Interview/Viva-Voce. Where more than one candidate obtains same grand total marks, the candidate who obtains more marks in the written examination will get preference. Where the marks obtained by such candidates in the written examination are also same, then the candidate who is senior in age will get preference. The High Court reserves the right to assign any Group-D position(s) to the selected candidates based on administrative requirement. The Gauhati High Court reserves the right to fix or alter the cut off mark in written examination and Interview/Viva-Voce. | |

5. HOW TO APPLY

Before applying online, candidates must possess a valid e-mail ID and Mobile Number which are mandatory for registration. E-mail ID should be kept active. **Though the system is designed to send e-mail immediately acknowledging the Registration Code, sometimes due to network congestion, the e-mail may not be delivered, hence the candidates are requested to note down the Registration Code.**

- II. Candidates need to upload scan copies of the following testimonial(s)/certificate (s) at the time of submission of online application.
 - a) Documents relating to age proof (admit card/ Birth certificate).
 - b) Documents relating to eligibility criteria.
 - c) Unemployment Certificate.
 - d) Permanent Resident Certificate of the District.
 - e) Indigenous inhabitant Certificate.

f) Certificate relating to disability (if any).

III. Application made in any other mode, except as indicated above, shall be summarily rejected without any communication.

Procedure for submission of online Application – GHCKB

Step 1: Register

To register as an applicant, a candidate has to provide primary credentials such as Username, Password, Email, Date of Birth and Mobile Number. Candidates are requested to use valid mobile number and email id.

Step 2: Login

Login using the credentials given during registration i.e. registered email and password.

Step 3: Instruction


Before proceeding to online application form go through the information (notifications and guidelines) given in the website.


Step 5: Upload Photo

- a. Upload recent passport photo image with clear background, preferably white color background.
- b. File size should be between 5kb – 150 kb.
- c. Image format should be .jpg and .png only.
- d. The dimension of the photograph image should be as indicated:



Step 6: Upload Signature

- a. Upload signature image with clear background, preferably white color background.
- b. File size should be between 5kb – 150 kb.
- c. Image format should be .jpg and .png only.
- d. The dimension of the photograph image should be as indicated:



Step 7: Upload Academic Documents

- a. Scan all required documents and compiled it in a single clear and readable PDF file.
- b. File format should be .pdf only.
- c. File size should be between 40kb – 4MB.
- d. Documents should be in the single PDF file:
- Education Qualification Class- VII and above

Step 8: Upload Caste Certificates

- a. Scan all required documents and compiled it in a single clear and readable PDF file.
- b. File format should be .pdf only.
- c. File size should be between 40kb – 4MB.
- d. Documents in the single PDF file should be in the following order:

- SC/ST/GEN/OBC/ Certificate
- Indigenous Certificate
- Unemployment Certificate
- Permanent Residential Certificate
- Others if any.

After successfully submitting all the forms, applicants will be directed to payment page.

7. Fee once paid shall not be refunded under any circumstances. The fee will also not be held in reserve for any other examination or selection.

8. Candidates are advised to apply online well before the closing date, in order to avoid potential last minute issues caused by heavy traffic on the website.

9. TERMS AND CONDITIONS:

- i.* Merely satisfying the eligibility criteria will not entitle a candidate to be called for the written examination/Viva-Voce etc.

- ii.** Candidates have to upload scanned copies of their documents/testimonials rather than submitting physical copies at the time of submission of online application. However, candidates have to produce their original testimonials regarding educational qualifications claim of reservation, certificate of indigenous inhabitant of the District, Permanent Resident Certificate , date of birth, caste, working experience(if applicable,) etc. at subsequent stages when asked for.
- iii.** Number of posts may vary at the time of final selection on either side.
- iv.** No person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the aforementioned posts.
- v.** The admission of candidates at all stages of the selection process shall be purely provisional and subject to their satisfying the prescribed eligibility criteria. If, on verification at any time before or after the selection process, it is found that a candidate does not fulfill any of the eligibility conditions, his/her candidature shall stand cancelled without any notice. Mere calling of candidate to the written examination/Interview etc. or issuance of admits cards/call letter etc. does not mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and the High Court reserves the right to reject the candidature of any candidate at any time.
- vi.** The provisional list of the candidates, with assigned Roll Nos. will be published in the High Court websites/District Court websites for the candidates' reference.
- vii.** No TA/DA shall be paid to the candidates for appearing in the written examination/Viva-Voce etc.
- viii.** For candidate's reference, answer keys of the question paper for the written examination will be made available in the Official websites after the examination.
- ix.** Candidates who are already in the Government Service in State/Central/PSU may apply after intimating their employers regarding submission of online application forms for the advertised vacancies. They shall have to produce "No Objection Certificate" from their present employer at the time of document verification and "Release Order" at the time of appointment.
- x.** The High Court may decide not to issue any admit card/call letter etc. to any candidate and may decide to call candidates to written examination/Viva-Voce etc. by publishing a notification in the official website and notice board of the High Court/ District Court. Candidates are advised to visit the Official website (<https://kohimahighcourt.gov.in/>) of the High Court/District Court regularly for updates and important information. Unnecessary correspondence should be avoided.
- xi.** Application form, which is incomplete in any respect, such as without the photograph and signature, is liable to be rejected summarily, unless otherwise decided by the High Court.
- xii.** The candidates, before applying for the posts, should ensure that they fulfill all the eligibility conditions. Any information submitted by an applicant in his/her application will bind the candidate personally. The candidate will be solely responsible for any mistake made by him/her in the application form and the High Court shall not be responsible or liable in any way.

- xiii.** The certificate for claim of reservation must be issued by the competent authority.
- xiv.** If any candidate is found canvassing directly or indirectly, his/her candidature will be rejected.


