3. Where there are two officers viz (Joint Registrar/ Deputy Registrar concerned) it shall be the prerogative of the Officer in higher Hierarchy to exercise the first option for reporting/reviewing. Delegation if any, shall be his/her discretion.
4. The Court Officer shall obtain the views of concerned Hon'ble Judge/Officer before documentation of APAR in respect of Grade-IV staff working in the Bungalows/residence of Hon'ble Judges/Officer.
