

NOTIFICATION NO. 19

Dated Guwahati, the 31st of March, 2026

In partial modification of Notification No. 79 dated 19.06.2023 and Order dated 21.08.2023 in this regard, the Gauhati High Court has been pleased to direct that henceforth, no amendment of the 'cause title', 'pleadings of cases', etc., filed in the Gauhati High Court will be permitted by hand. Parties seeking amendment of the 'cause title', 'pleadings of cases', etc., shall be required to file a fresh / amended 'cause title' or amended 'pleadings', etc., **in the Filing Section of the Registry, along with a true copy of the relevant order allowing the amendment.**

In case amendment in the cause title, pleadings of cases, etc., is under the orders of the Court, filing of the amended cause title, pleadings, etc., will suffice. However, parties desirous of seeking amendment in the cause title, pleadings, etc., of their own accord will be required to do the same by filing an Interlocutory Application (IA).

Pursuant to such filing, the Filing Section shall accept the amended documents provided they are free of material defects and comply with existing High Court Rules. Once accepted, the Filing Section will transmit the documents to the concerned Judicial Section, **and it will be the duty of the concerned Judicial Section to immediately update the amended portion in the Case Information System (CIS), if so required.**

This Notification shall come into effect immediately.




