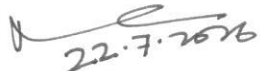
Candidates are directed to bring the following relevant testimonials in original, along with a set of self-attested photocopies. The self-attested copies shall be handed over at the time of the document verification.

9. Certificate(s) of continuous Practice of not less than 7 years [Will have to provide certificate of continuous practice issued by competent authority {BAR(s) in which the candidate is practicing, as an Advocate in Court of Civil and Criminal Jurisdiction,

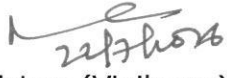
