Pursuant to the advertisement No.HC.XXXVII-01/2026/165/R.Cell dated 19-05-2026 in connection with direct recruitment of Judicial Assistant in the Kohima Bench, the Gauhati High Court has been pleased to publish the list of candidates who are provisionally found eligible to appear in the OMR based written examination.

Further, a Reject list of applicants whose candidatures have been rejected for not fulfilling the eligibility criteria as per the advertisement has also been published herewith. Any candidate whose name appears in the reject list and who is aggrieved by such rejection may submit her/his grievance, if any, regarding non-inclusion of her/his name in the provisional list, through e-mail at ***ghc.rcell2013@gmail.com*** from their registered email-id on or before 14-08-2026. She/He shall mandatorily attach supporting document(s) to substantiate her/ his claim and mention clearly the name of the post, Registration Number and Date of Birth. No grievance received after the stipulated date shall be entertained.

Moreover, candidates belonging to the category of Persons with Benchmark Disabilities (PwBD) may avail the facility of a scribe in accordance with the guidelines/instructions laid down in Notification No. HC.XXXVII-08/2026/75/R.Cell dated 18-03-2026 by submitting scanned copies of duly filled **Appendix-I** and **Appendix-II** via email at- ***ghc.rcell2013@gmail.com*** from his/her registered email ID on or before 05:00 pm of 14-08-2026. Candidates must clearly mention their Name, Name of the Post, and Roll Number in the email. The Notification dated 18-03-2026, containing detailed guidelines/instructions for availing the facility of a scribe by PwBD candidates, is enclosed herewith along with the prescribed formats of *Appendix-I* and *Appendix-II*.

Calling of the candidates to the written examination is purely provisional and subject to verification of all relevant documents and fulfillment of the eligibility criteria as prescribed in the relevant advertisement dated 19-05-2026. If, at any stage it is found

that a candidate does not fulfill the eligibility conditions, her/his candidature shall be liable to be cancelled without further notice. No TA/DA will be paid for appearing in the aforesaid examination. The schedule of the written examination will be notified at a later stage.
