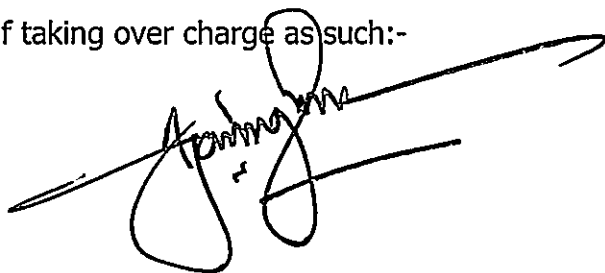
He will first hand over charge of his Court and Office to Shri Atoka Achumi, District & Sessions Judge designate, Zunheboto and then proceed to join his new assignment.

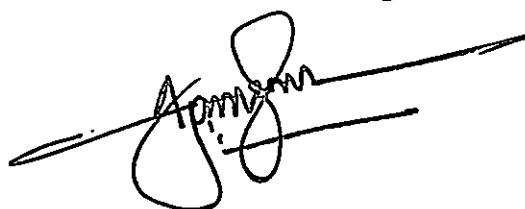

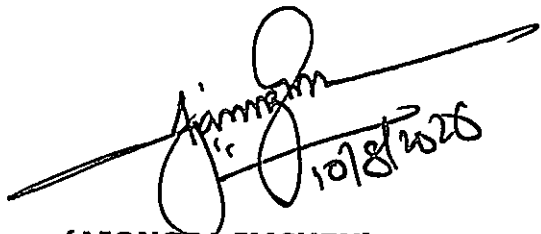
